Power Department -Temporary Up-gradation of 167 Assistant Engineers to Assistant Executive Engineers in Kerala State Electricity Board Ltd -Sanctioned- Orders issued.

ORDER

As per letter read as first paper above the Secretary, Kerala State Electricity Board has requested to upgrade the cadre of 167 Assistant Engineers to Assistant Executive Engineers in Kerala State Electricity Board to enhance organizational effectivness as well as to create a more conducive atmosphere in the organization.

Government have examined the matter in detail and are pleased to accord sanction for temporary up-gradation of 167 Assistant Engineers to Assistant Executive Engineers subject to the following conditions:-

- Assistant Engineers will be promoted based on existing seniority and no re-fixation of pay will be allowed.
- of Rs. 50/- pm. The additional financial commitment shall be borne by the Board itself.
- iii) The benefit of personal up-gradation shall have prospective effect only and is applicable to those who are already in service at the moment. Those who are on long leave which will not count for pension/increment/Higher Grade will not be eligible for the up-gradation.
- iv) Temporary Up-gradation of 167 Assistant Engineers to Assistant Executive Engineers shall be permitted till their retirement or promotion to the next higher post which ever is earlier and absorbed automatically in the arising Assistant Executive

Engineer vacancy till the 167 personal upgradation are covered. No more appointment of Assistant Engineers in the 167 posts so upgraded will take place until these 167 posts are adjusted and no more promotion to the post of Assistant Executive Engineer will take place until the 167 temporary upgradation is adjusted.

- v) There shall not be any structural changes in the existing pattern of offices.
- vi) Every year the Board shall ensure the status of ratio of Assistant Engineer to Assistant Executive Engineer and intimate the same to Government until the original ratio of Assistant Engineer and Assistant Executive Engineer is restored.
- vii) This will not be quoted as precedent.
